Having reviewed Notice of Non-Compliance No. **53-2265** and/or Cessation Order No. N/A the Department is hereby proposing a penalty assessment in the amount of **\$1,300.00**. A copy of the proposed penalty assessment worksheet is attached. Please note that this proposed penalty assessment is based upon information currently available to the assessment officer. If additional information becomes available, the Cabinet may determine that this proposed penalty is not appropriate and may seek a different amount. Also, if you choose to negotiate a settlement prior to the initiation of a penalty assessment conference, you may contact the Director of the Division of Mine Reclamation and Enforcement, 300 Sower Boulevard, Frankfort, KY 40601, telephone (502) 564-2340.

Should you decide not to negotiate, you have three (3) options remaining to resolve the proposed penalty assessment. You may (1) choose not to contest the amount of the proposed penalty assessment or the fact of violation in which case a final Order of the Secretary will be entered in accordance with 400 KAR 1:110 Section 3(5); (2) request a penalty assessment conference to contest the proposed penalty assessment (*if you request a penalty assessment conference, you may subsequently file a petition for an administrative hearing, within thirty (30) days of receipt of the conference officer's report, to contest the proposed penalty assessment and/or concurrently contest the fact of violation pursuant to 400 KAR 1:110 Section 3(4)(d)*); or (3) file a petition for an administrative hearing to contest the proposed penalty assessment and/or concurrently contest the fact of violation pursuant to 400 KAR 1:110 Section 3(4)(d).

**If you desire a penalty assessment conference or an administrative hearing, you must file a request or petition with the Office of Administrative Hearings within thirty (30) days of receipt of this notice. If you fail to respond within thirty (30) days of receipt of this notice, the Secretary of the Energy and Environment Cabinet will enter an appropriate final Order in conformity with 400 KAR 1:110 Section 3(5).**

*Note: The Kentucky Bar Association has determined that the appearance of an individual who is not a licensed attorney, on behalf of a third person, corporation, or another entity, at a penalty assessment conference constitutes the unauthorized practice of law. Corporations or other entities must be represented by counsel at penalty assessment conferences. Individuals may represent themselves;*
